Before the business of the Meeting, Mr Tyreman of Sawyers Crescent raised a number of issues:

Following letters sent by the Clerk, and with only one exception, the incidence of parking on the grass verges in Sawyers Crescent is much reduced.

Traffic in Low Green is very bad, particularly at school times. There is no "School" sign, and Mr Tyreman feels that one 20 mph sign is insufficient.

There is evidence of drug use and underage drinking in the snicket by the school (Yorkfield Lane). This is a matter for the police, but the situation would be helped if the undergrowth was cut back.

It is noted that the footpath on Sawyers Crescent is going to be repaired.
