Cllr Mrs Taylor had attended the most recent Ward Meeting. The Ward Committee did have a total budget of £36,000, from which grants totalling £8,375 had been agreed for Copmanthorpe. CYC has now removed £30,000 of this from the Ward and given it to the new Fairness Commission. This will impact on, among other things, the street lighting in Copmanthorpe.

#### 13. CORRESPONDENCE

We are informed by CYC that they intend to press ahead imminently with the move to electronic consideration of planning applications. In light of this we need to get up to date quotes for the necessary equipment – laptop, screen, projector and memory stick. It is noted that CYC's Planning Portal does not work, and has never worked properly, and neither has the email notification system.

The Chairman was among 50 people who attended a meeting hosted by Julian Sturdy, MP in Stockton-on-Forest. Matters discussed included the National Planning Policy Framework which fits with the Localism agenda. There have been lots of objections to the Core Strategy and the Inspector is known to have considerable concerns. It is possible that we may be able to appeal against decisions against which we have previously objected.

Proposals for changes to Ward boundaries are being reconsidered.

A request for funding to bind old copies of the Village Newsletter, covering 2005-11, for placing in the library has been received. The cost would be £154. It was AGREED that a grant of half the cost would be made. In return the Clerk is to request copies of all the old photographs which they have, to go on the Parish Council website.

A letter of resignation is received from Cllr Brian Bell. The Clerk to write to thank him for his years of service on the Parish Council.
